Dear Douglas Corrello:

Your brief/appendix, received 01/16/2018, has been reviewed and is deficient in several aspects. For the brief/appendix to be filed, the following noted deficiencies must be corrected within 15 days or the appeal may be subject to dismissal.

The Appellate Court is a review court and as such the appendix shall contain all relevant documents essential for the proper consideration of the issues on appeal. All documents contained in the appendix must be part of the record below and in their original form. It is improper to refer in the brief to any fact or evidence which was not part of the record in the trial court or to include any such material in the appendix. Do not include papers filed in the Appellate Court in the instant appeal. These documents are readily available to the Court but improper to include as they are **not part of the trial court record. Portions of the record that must be included in the appendix filed by the appellant are set forth in R.2:6-1(a).**

The appendix **may** contain documents per R.1:38-39d)(1) & (13) that are required to be excluded from public access. These documents must be removed from the appendix and submitted in a separate appendix marked as confidential. R.2:6-1(a)(3)

Specific documents regarding family part proceedings must be submitted in a confidential appendix. These confidential documents include child custody evaluations, parenting time, visitation plans, reports and records.

- The stenographic transcript shall be excluded from the appendix and filed separately unless the transcripts were submitted in the trial court as an exhibit or attachment. R.2:6-1(a)(1)

The court does not accept quad transcripts. You may, however, submit two to a page compressed transcripts. The standard is fixed by the Administrative Director of the Courts. If you have questions regarding this standard, please contact the Appellate Transcript Unit. R.2:5-3(e)

- Please submit 1 additional copy of the transcripts dated: 03/30/17 and 07/12/17
- Other:** You must revise the transcript designation located on page VII of the brief. The transcript designated as 1T should refer to the proceedings of March 30, 2017, not March 3, 2017.
- All responding briefs are due 30 days from the receipt of the brief corrections.**

Five copies of a revised brief/appendix correcting the noted deficiencies must be submitted within 15 days of receipt of this notice. Then, two copies of same should be served on each of the other parties to the appeal and a proof of service submitted to this office.
